## **Duties & Responsibilities**

- As a member of the airport maintenance team this position will be responsible for operating assigned heavy equipment and performing general labourer duties as required.
- Maintain all buildings and County facilities at the Airport in a neat and tidy manner as directed by the Manager of Airport.
- Perform vehicle pre trips, work orders, inspections, including safety inspections on property, buildings, and equipment. Record on Enterprise Asset Management and Enterprise Resource Planning Systems, or other systems.
- Service and maintain assigned airport equipment and perform minor operational repairs. May be required to assist the mechanic in major repairs.
- Respond to customer/stakeholder inquiries and service requests in a courteous and professional manner and report to the Airport Manager.
- Report all deficiencies on equipment and scheduled services to the Manager of Airport immediately.
- Adhere to the County's confidentiality requirements, including the appropriate use of information and maintaining the security of all acquired information relating to employees, businesses, and/or residents of Woodlands County.
- Maintain knowledge of and comply with relevant legislation, policies, and procedures, while
  continually seeking learning opportunities to enhance knowledge in relevant fields of work.
- Participate, in good faith and to the best of their ability, in all training and development programs, as assigned by Woodlands County.
- Maintain knowledge of and comply with all Occupational Health and Safety legislation, as well
  as the County's Occupational Health and Safety policies; comply with all safe work procedures
  and OH&S requirements; monitor compliance with OH&S regulations and participate in the
  internal responsibility system by reporting any non-compliance to supervisor/manager.
