Seasonal Positions

Community Ambassador – Competition No. 2025-27

The Woodlands County ambassador is a unique role that requires an outgoing, media savvy, engaging individual that is willing to represent the County and connect with our communities' residents.

Duties Include: Gathering survey data, meeting with community stakeholders and small businesses, attend events and create a catalog of photos and videos to share on social media platforms.

Preference given to applicants that have a background in public relations, communications or graphic design.

Applicants must have a valid Alberta Class 5 License and be able to begin duties by May 4, 2026.

Parks & Recreation Seasonal Labourer – Competition No. 2025-28

Duties include: Maintenance of all Woodlands County day-use and campground facilities including cutting grass, whipper snipping, cleaning outhouses, picking up garbage, painting buildings, installation of signs, picnic tables and fire rings, and the planting and maintenance of flower beds. Provide labour and support during the construction and maintenance of park facilities as required.

Preference may be given to applicants with experience operating lawn maintenance equipment.

Applicants must have a valid Alberta Class 5 License and be able to begin duties by May 4, 2026.

Infrastructure Services Seasonal Labourer – Competition No. 2025-29

Duties include: Grounds and road maintenance including sign replacement, pothole patching, operating small equipment and other various labour duties. Provide flagging and traffic control when directed on road and bridge maintenance projects. Provide support to equipment operators and drivers when required.

Preference may be given to applicants with experience operating light duty equipment.

Applicants must have a valid Alberta Class 5 License and be able to begin duties by May 4, 2026.

Agriculture Services Seasonal Labourer – Competition No. 2025-30

Duties include: Identification and reporting of prohibited and noxious weeds, communication of weed control responsibilities to residents and issuing enforcement notices as required by the Alberta Weed Control Act. Manual weed control and assistance with pesticide application, record keeping, data entry and other various labour duties as required within the scope of the position.

Preference may be given to applicants with working knowledge of the Alberta Weed Control Act.

Applicants must have a valid Alberta Class 5 License and be able to begin duties by May 4, 2026.
