



## **Woodlands County Groat Creek Recreation Area**

### **GROUP RESERVATION CAMPING AGREEMENT**

#### **General**

Woodlands County operates the Groat Creek Group Campground.

Woodlands County Bylaw 374/11 provides for the control and operation of the County campground.

The Groat Creek Group Campground is available for rentals starting the May, Victoria Day long weekend to the October, Thanksgiving Day long weekend. Reservations can be made through the Whitecourt Forest Interpretive Center at 780-778-3433 or 1-800-313-7383 starting January 4, 2016 at 8:30 A.M. for the 2016 camping season.

#### **Site Amenities**

Group area includes 6 back-in sites and 4 drive-in/pull-off sites all with their own picnic table and fire ring. Shelter has wood stove and is equipped with power via generator hook-up. Site also has an outhouse, group fire pit, wood shed, playground and wooden playhouse.

*Note: Group site maximum capacity is 10 camping accommodation units.*

#### **Reservations**

1. Full payment for your intended stay is required at time of reservation. A \$50.00 non-refundable reservation fee is included. If a cancellation is required, the procedure is as follows:
  - a. If a reservation is cancelled more than 10 days prior to the arrival date payment is refunded less the \$50 reservation fee.

- b. If the reservation is cancelled with less than 10 days notification prior to the arrival date there will be no refund. A refund less the \$50 reservation fee will be issued if the site is rebooked by another party.

### **Group Camping Rates**

1. Camping fees are as follows:
  - a. Weekend rate(Friday/Saturday): \$400.00  
Includes one cord of firewood (4 x 4 x 8 feet)
  - b. Additional nights stay added to corresponding weekend: \$140.00  
No firewood included
  
2. Camping fees are payable in full to "Woodlands County."

*Note: Maximum stay of 7 nights/group.*

### **Day Use Rates**

1. Day use fees are as follows:
  - a. Day use rate (Monday to thursday): \$140.00  
Check-in 12 P.M./check-out 11 P.M.  
No firewood included
  
2. Day use fees are payable in full to "Woodlands County."

### **Firewood**

1. Additional firewood can be ordered at the time of booking for an additional cost. Firewood costs are as follows:
  - a. \$100.00/pick-up truck (2' X 2' X 8')
  - b. \$150.00/cord (4' X 4' X 8')

### **Access to the Group Campground**

1. Keys to the group campground are available for pick up the first day of rental at the Whitecourt Forest Interpretive Center (please phone 780-778-3433 or 1-800-313-7383) to arrange for pick up time). The keys must be returned to the Whitecourt Forest Interpretive Center on the last day of the rental. There is a \$20.00 cash key deposit required at time of key pick up. Check in time is 12:00 P.M.
  
2. Check out time is 2:00 P.M. on the last day of rental. Please ensure the gate is locked, all facilities are clean and garbage is deposited in provided receptacles.

## Campground Regulations

1. All rules and regulations of the campground will be followed by all campers and visitors. Violation of any of these regulations stated within this agreement and within Bylaw 374/11 may terminate your weekend registration with no refund of pre-paid fees, and may be subject to fines and/or criminal charges. 2. Overnight camping at the campground is intended for use by groups that have reserved the campground and have read, understood and signed the camping agreement.
3. This agreement must be produced by the booking party at any time during the group's stay in the park upon request by an Agent of the County and/or Peace Officer.
4. A maximum stay of 7 nights will be permitted for each group reservation.
5. A maximum of 10 Camping Accommodation Units are permitted to occupy the campground at one time.
6. No person shall remove, deface, injure, damage or destroy any property, object, sign or other feature within the Groat Creek Recreation Area, whether naturally occurring or man-made.
7. Campfires are permitted in designated areas only, and must be kept under control and attended to at all times. Campfires must be fully extinguished prior to leaving the campground. No burning of pallets.
8. Waste known as grey water or sewer must be contained and disposed of at designated facilities. A sani-dump is located at the Whitecourt Forest Interpretive Center.
