AIRPORT FUEL SYSTEM

Administration provided council with some background information and a discussion ensued regarding tank location and sole sourcing.

MOVED by Councillor Govenlock that Council agree to sole source the supply, delivery and sale of aviation fuel to Rotaiva for a 3-year term on the basis that Rotaiva:

- obtains all required permits
- remits royalties to Woodlands county on a basis similar to past royalties
- obtains and maintains a minimum of \$5,000,000 general liability insurance
- obtains and maintains a minimum of \$5,000,000 Automobile third party liability insurance
- additionally, insures the county under the general liability policy
- agrees to indemnify and hold harmless the county for any and all injuries or claims that result from the contractor's negligence
- enters into a contract with Woodlands County that has been prepared by the county's solicitor
- That tanks be placed in a location as to not interfere with the operation of the airport or excavation of existing underground fuel tanks.
